

**Street Lighting Service****Availability**

Available on a year-round basis to cities, town and villages from dusk to dawn the delivery of kilowatt-hours for lighting purposes when ten or more units are installed. This rate is subject to the established rules and regulations of the Cooperative.

**Term of Service**

The term of service under this schedule shall be by contract for an initial period of at least 10 years and on a continuing basis thereafter.

**Rate**

Normal Service:

Normal service is defined as service using the Cooperative's standard luminaries, lamps and brackets not over four feet in length installed on existing wooden distribution system poles having an existing overhead secondary circuit available.


**Legacy Lamps**

Mercury and Sodium Lamps are designated as "Legacy Lamps." Legacy Lamps will be available at existing lighting installations and will not be available for new lighting installations after July 5, 2021. Commencing on July 5, 2021, LED Lamps shall be installed for all new lighting installations. If a Legacy Lamp fails, the Cooperative may replace it with an LED Lamp. The Cooperative may require the replacement of a working Legacy Lamp with an LED Lamp if the Cooperative determines it to be consistent with good engineering practice.

Closed Service:

Adjustment Clauses

This rate is subject to adjustment for costs under provisions of rate schedules TC, FR and CA plus other adjustments as may be approved from time to time by the Maine Public Utilities Commission.

Additional Charges

Special, non-standard brackets longer than four feet will be installed upon request at a charge dependent upon the length and installed cost of the cost of the bracket.

Special ornamental poles may be added at a charge mutually agreed upon prior to the time such poles are installed. For poles of this type, a special contract is required.


When service is provided that requires facilities that are standard with the Cooperative, but are in excess of the cost of those facilities furnished under normal service, an additional monthly or one-time charge for such excess facilities will be made.

If an existing pole is not used, the Cooperative will install a wooden pole of suitable size. The charge for this pole will be \$50.00 at installation plus \$3.50 per month.

Conditions of Service

All street lighting equipment including lamps, fixtures, photo-electric controls and necessary street lighting circuits, transformers, poles, guys and fittings will be furnished, installed and maintained by the Cooperative.

Normal lamp replacements will be made by the Cooperative without additional charge, except that any damage to lamps and luminaries resulting from vandalism shall be charged to the customer, at cost, as a separate item on the monthly bill for service. Outages should be promptly reported.

Service to street lights added subsequent to an initial installation will be provided in accordance with all the terms and conditions set forth in this rate.

Maintenance and lamp replacement will normally be performed only during regularly scheduled working hours of the Cooperative. For its convenience and at its sole option, the Cooperative may perform maintenance and lamp replacement at other times.

When a customer requests a change in existing street lighting equipment that has not reached the end of its normal useful life, the customer will be required to pay for any relocation costs of the equipment. When a customer requests the discontinuation of the use of street lighting equipment prior to expiration of the TERM OF SERVICE, the customer will be required to pay either the balance due on the contract, or the installation and removal cost of the equipment, whichever is less.

Terms of Payment

The above rates are net. Payment of the current monthly bill shall be made within 25 days from the date of mailing. In the event that the bill is not paid within the 25 day period, the charges become subject to a late payment charge as established in the Terms and Conditions.
